# 1 General Information

This operation manual is part of the EndoPAT<sup>TM</sup>x system.

#### 1.1 Intended Use of the EndoPAT<sup>TM</sup>x Device

The EndoPAT<sup>TM</sup>x device is a non-invasive device, intended for use as a diagnostic aid in the detection of coronary artery Endothelial Dysfunction (positive or negative) using a reactive hyperemia procedure.

The EndoPAT<sup>TM</sup>x Device has been shown to be predictive of coronary artery Endothelial Dysfunction in the following patient population: patients with signs or symptoms of ischemic heart disease, who are indicated for coronary artery angiography, but who lack angiographic evidence of obstructive coronary artery disease. The device is intended to be used in a hospital or clinic environment by competent health professionals.

The EndoPAT<sup>TM</sup>x device is not intended for use as a screening test in the general patient population. It is intended to supplement, not substitute, the physician's decision-making process. It should be used in conjunction with knowledge of the patient's history and other clinical findings.

## 1.2 Performance and clinical study information



#### Note

EndoPAT<sup>TM</sup>x is the successor of EndoPAT<sup>TM</sup>2000, the currently available device, with the same intended use, same functionality, and equivalent performance. The information below is based on EndoPAT<sup>TM</sup>2000 results.

The following sensitivity and specificity data were revealed from a clinical study that was performed at the Mayo Clinic Rochester, MN and that had been designed to evaluate the safety and effectiveness of the EndoPAT<sup>TM</sup>2000 device as an aiding tool in the diagnosis of coronary artery Endothelial Dysfunction versus a Gold Standard for coronary Endothelial Dysfunction evaluation, the Intra-coronary Acetylcholine (Ach) Challenge method:

The Gold Standard for Endothelial Dysfunction evaluation, the Intra-coronary Acetylcholine (Ach) Challenge method, is routinely performed at the Mayo Clinic.

According to the Intra-coronary Acetylcholine (Ach) Challenge method, a catheter is positioned in the origin of the left main coronary artery and Ach is infused with incremental concentration followed by coronary angiogram. The coronary artery diameter is measured in the segment 5mm distal to the tip of a Doppler wire using a computer-based image analysis system. Average peak velocity (APV) is derived from the Doppler flow velocity spectra and coronary blood flow (CBF) is determined as:  $\pi^*$ (coronary artery diameter/2)<sup>2\*</sup>(APV/2). Endothelium-dependent coronary flow reserve is calculated as percent change in CBF in response to the Ach challenge.

Normal coronary endothelial function is defined as an increase in CBF of >50% and an increase or less than 20% decrease in the coronary artery diameter in response to the maximum dose of intra-coronary Ach ( $\Delta$ CBF > 50% and  $\Delta$ CAD > -20%)

# **Synopsis of Clinical Study Protocol:**

#### **Objectives:**

To evaluate the EndoPAT<sup>TM</sup>2000 device relative to a gold standard procedure as a diagnostic aid for detecting coronary endothelial dysfunction.

#### Methodology:

Patients, who had been referred to diagnostic angiography cardiac catheterization laboratory for diagnostic angiography secondary to signs or symptoms of ischemic heart disease and suspected coronary endothelial dysfunction and were found to have normal or near to normal angiogram, underwent Intra-coronary Acetylcholine (Ach) challenge test to assess attenuation in required increases to coronary blood flow (CBF) and coronary artery diameter (CAD), where each of these parameters served as an indicator for coronary endothelial dysfunction. Coronary endothelial dysfunction is diagnosed if one of the following changes is observed in response to the Ach challenge test:  $\Delta CBF \le 50\%$  OR ΔCAD < -20%. Patients were then evaluated using the EndoPAT<sup>TM</sup> 2000, which measures Peripheral Arterial Tone (PATTM) signal changes at the fingertip, to a reactive hyperemia challenge. The PATTM signal is a measure of the digital pulsatile volume changes and is measured with a non-invasive disposable PAT<sup>TM</sup> probe. The reactive hyperemia procedure consists of a 3-10 minute baseline recording, 3-5 minutes of blood flow occlusion to one arm using an lower arm blood pressure cuff, and 3-5 minutes of recording after cuff release. The expected response is of a post occlusion increase of the PAT<sup>TM</sup> signal amplitude and the PAT<sup>TM</sup> score is provided automatically by the system's software and is basically the ratio between the post- to pre- occlusion average signal size, corrected for systemic changes and baseline level.

Planned Enrollment: 100 patients

**Actual Enrollment**: 111

Safety Analysis Cohort: 110 (One patient withdrew consent)

**Efficacy Analysis Cohort**: 94

#### Criteria for inclusion:

- Patient Age > 17
- Patient referred to diagnostic angiography
- Normal or near normal angiogram (< 30% stenosis)
- Evaluation in catheterization laboratory
- · Signed informed consent

#### Criteria for exclusion:

- Deformities of fingers that preclude adequate signal acquisition with the EndoPAT<sup>TM</sup>2000 device.
- Short acting NTG less than 6 hours prior to study and calcium channel blockers or alpha-blockers less than 24 hours prior to study.

# 1.8 Safety Precautions

Only the power cable that is provided within the EndoPAT<sup>TM</sup>x package will be used for the system.

# 2 System Overview

The EndoPAT<sup>TM</sup>x device is a computer-based system for non-invasively assessing vascular endothelial dysfunction. It is based on the use of Peripheral Arterial Tone (PAT<sup>™</sup>) signal technology, during a clinically established procedure, which measures post-ischemic vascular responsiveness following upper arm blood flow occlusion.

PAT<sup>TM</sup> signal technology is a newly developed proprietary technology for measuring the magnitude and dynamics of arterial tone changes in peripheral arterial beds. PAT<sup>TM</sup> technology measures peripheral arterial tone, by recording digital pulsatile volume changes without involving painful and risky invasive procedures.

The non-invasive PAT<sup>TM</sup> probe, used with the EndoPAT<sup>TM</sup>x device, is a new type of finger plethysmograph that imparts a uniform pressure field to the distal two thirds of the finger including its tip. It was designed to avoid many of the existing problems associated with conventional plethysmographic devices such as distal venous distention and the resulting induction of reflex veno-arteriolar constriction, and it has a higher dynamic range of changes and better clamping to the finger. Its extended pressure field also excludes spurious venous signals while continuously recording the digital arterial pulse wave.

Studies using the EndoPAT<sup>TM</sup>x device are easily performed in any clinical setting, with a minimal period of training required. The system is fully computerized, and the recorded signals are simultaneously displayed on a PC or laptop screen. Recorded data is automatically saved, facilitating subsequent review and computerized automatic analysis. Due to the fact that analysis is performed automatically, there is no question of inter or intra operator interpretation variability.

The PAT<sup>TM</sup> software program is easy to use and has two main operating modes:

- Real time recording and display
- Off-line display and analysis

Since the system records data in real time, it is possible to follow events as they occur.

Data acquired during a study can be downloaded to the computer's hard disk and may subsequently be retrieved for off-line review and automatic analysis.

EndoPAT<sup>TM</sup>x is the successor of EndoPAT<sup>TM</sup>2000, the currently available device, with the same intended use, same functionality, and equivalent performance.

#### 2.1 How to Use this Manual

This Operation Manual is designed as a general guide to help the user in operating the system. The user will find step-by-step instructions for performing a PAT<sup>TM</sup> study, and instructions for maintenance of the system.

Set of 6 foam finger anchors

USB cable

The supplied EndoPAT<sup>™</sup>x software package can be used with any Windows<sup>TM</sup> computer running Windows 10.

Do not place anything on the EndoPAT<sup>TM</sup>x device.


## 3.2 System description

The EndoPAT<sup>TM</sup>x device front panel has the following indicators (see Figure 2 – EndoPAT<sup>TM</sup>x System):

- POWER LED indicator
- COMM LED indicator for the device-computer communication status
- ERROR LED indicator for error status
- Probes' Deflate and Inflate buttons

The following connectors are located on the rear panel (see Figure 2 – EndoPAT<sup>TM</sup>x System):

- Two pneumatic input connectors for attaching the pneumo-electric tubing, connecting the PAT<sup>TM</sup> probes to the EndoPAT<sup>TM</sup>x device
- Power supply AC Inlet connector with ON/OFF switch and fuse drawer
- USB Communication port



# 3.3 Connecting the EndoPAT<sup>TM</sup>x device to the computer



#### NOTE

The EndoPAT<sup>TM</sup>x system requires the use of a USB cable (supplied with the system) for connecting to the computer.

1. Place the EndoPAT<sup>TM</sup>x device and computer on a stable platform in close proximity to the examination bed or chair. The device should be placed at a distance from the bed or chair that is shorter than the pneumo-electric tubing (less than 1.8 meters/ 6 feet).



#### NOTE

Refer to APPENDIX C: MANUFACTURING DECLARATIONS ACCORDING TO IEC 60601-1-2 for specific installation instructions for avoiding electro-magnetic interference between the EndoPAT<sup>TM</sup>x and other electrical equipment.

- 2. Connect the USB cable to the communication port on the EndoPAT<sup>TM</sup>x device, and to one of the computer's USB ports. Use the strain relief knob on the EndoPAT<sup>TM</sup>x rear panel for ensuring that the USB cable is not unintentionally detached from the device (Figure 3).
- 3. Connect both pneumo-electric tubing to the EndoPAT<sup>TM</sup>x device's back panel pneumo-electric connectors and secure by hand tightening the screws.
- 4. Make sure the power switch is off. Connect the power supply first to the EndoPAT<sup>TM</sup>x device and then to an electrical outlet. Turn the power switch on.
- 5. The power indicator light will glow, indicating that the power is turned on.

#### 3.4 EndoPAT<sup>TM</sup>x Software Installation



#### NOTE

Prior to software installation, verify that you are in full system administrator mode with full privileges. Otherwise, the installation might not succeed and could cause operational problems.

1. Close all open applications operating on the computer, including background applications, before installing the EndoPAT<sup>TM</sup>x software.



#### NOTE

Uninstall previous EndoPAT<sup>TM</sup>x software versions prior to installing a newer version. To uninstall the software please refer to section 3.5.

Make sure to backup all your patient data and system configuration prior to uninstalling any software.

- 2. Insert the EndoPAT<sup>TM</sup>x software CD into the CD drive. The installation program will load automatically. Alternatively, you may execute the Itamar-Installer application from the installation CD.
- 3. The install wizard prepares the computer for installation. When prompted, click next to proceed with the installation.
- 4. Click "Next" to set the default target folder for software installation or click "Change" to select a different folder for the installation.




#### NOTE

It is not recommended to install the program in the "My Documents" or "Desktop" folders.

- 5. Press "Install Now" to complete the installation process or "Back" to review or change any of your installation settings.
- 6. Press "continue" when installation permission is requested.
- 7. Press "Next" when the EntoPAT<sup>TM</sup>2000 installation wizard is opened
- 8. Sign "Accept" and "Next" on License Agreement then "Next" and "Install"



- 9. When screen appears press "No" (don't confirm restart!)
- 10. When the below screen appears click on "Summary"



- 11. Then you should see "Itamar EPx was successfully installed"
- 12. Click on the small arrow on the right corner and choose "Quit"
- 13. Confirm to stop the installation and exit the installer on the popup window by clicking "OK"
- 14. An icon will be added to the desktop after installation link to the  $EndoPAT^{TM}x$  application.



#### WARNING

The EndoPAT<sup>TM</sup>x device is a PC operator device. Use antivirus software and password protected screen saver to protect your system and files.

You should also consider routine backups to ensure your ability for data recovery if needed.

# 3.5 Uninstalling EndoPAT<sup>TM</sup>x Software

Use the EndoPAT<sup>TM</sup>x install wizard to uninstall the application from your PC.

# 3.6 Shutting Down the System

- a. Shut down the  $EndoPAT^{TM}x$  software program by clicking on the "X" on the upper right corner.
- b. Switch OFF the EndoPAT<sup>TM</sup>x device using the on/off switch on the back panel.

# 4 EndoPAT<sup>TM</sup>x Application Description

The following screens describe the full application. Viewer mode has the relevant subset of the controls (the title of the screen might be different).

# 4.1 EndoPAT<sup>TM</sup>x User Roles

There are three user roles for the EndoPAT<sup>TM</sup>x:

- 1) EndoPAT<sup>TM</sup>x Operator: assigned with privileges for conducting EndoPAT<sup>TM</sup>x studies, managing patients and data, exporting/importing, and generating printing automatic reports.
- 2) EndoPAT<sup>TM</sup>x Doctor (Reviewer): review and edit EndoPAT<sup>TM</sup>x study signals, access to a comparison view of all test results of single patient, generate the report for patient view.
- 3) Local Administrator is assigned with privileges to set username, role, and password as well as import export studies and generate system logs.

Roles are assigned separately to individual EndoPAT<sup>TM</sup>x user.

## 4.2 Creating User Roles

Login Screen

From the Windows™ desktop double click the EndoPAT<sup>TM</sup>x Application icon to open the EndoPAT<sup>TM</sup>x Login screen.

By default, the basic users exist. To create specific users the designated Local Admin should log in.

Once logged in as Local Admin press on the arrow on upper right side of the screen. A pull-down menu will open with optional tasks (Figure 5 - Local admin pull down menu).




Figure 6 - List of Users




Figure 7- Create User




Figure 12 - New Patient

Patient information and risk factor parameters can be updated/edited.




Figure 13 – Patient Record and New Study





Figure 14 - Edit/Update Patient Info.




Figure 15 - Insert Risk Factors-Framingham




Figure 16 - Insert Risk Factor - Reynolds





Figure 17 - Insert Risk Factor - European

# 4.3.3.3 Access previous patient EndoPAT<sup>TM</sup>x test records.




Figure 19 - Previous Study Options

## 4.4 Conducting EndoPAT<sup>TM</sup>x Study – Operator

The **Test** section of the screen (Figure 13) is used to finalize new study information and initiate an EndoPAT<sup>TM</sup>x Study. Please note that to initiate a new test, the EndoPAT<sup>TM</sup>x device must be turned on and connected.

Patient setup and test environment are important for study success, review Preparing for a Study, section 5, before commencing a new test. Review section 6 Conducting an EndoPATTMx Study, for additional important details.

This section will describe the screens as seen by the operator when performing an  $EndoPAT^{TM}x$  test.

# 4.4.1 Initiating a new EndoPAT<sup>TM</sup>x study

In the TEST section of patient information screen, insert patient's blood pressure information and visit number.




Figure 26 - New Study Screen

The main screen of EndoPAT<sup>TM</sup>x study includes the following main sections:

- System stability
  - Indication of leakage detection
- PAT<sup>TM</sup> Signal Waveform Viewer
  - Display the acquired PAT<sup>TM</sup> signals from Probe A and B
  - O Separate gain for each signal Max Gain button enables optimal view of occlusion quality in the occluded signal. It should be selected on the designated occluded hand just before occlusion.
  - o Study stage bookmarks and Study Control buttons enable navigation between the study stages.

    Selecting the enabled (green) stage icon will display the signals of that stage on the screen and enable navigation between the various stages.
  - Once Baseline, Occlusion or Post Occlusion are selected, a timer will display the recorded section duration, the next stage will be enabled (green) following defined recording time of present stage.

o Stop the study in middle of test if needed.



- Navigation between study stages
- o Inflate and Deflate buttons for patient setup

# 4.4.3 Standby Stage

Once probes are properly connected (see section Preparation of fingers and hands before a study), and the system completes its internal tests, the Standby button turns enabled ( standby )

When Standby button is clicked, the system inflates the probes to pre-configured

pressure, starts the PAT<sup>TM</sup> signal display and Standby button changes to ( standby

In Standby mode the system displays the signals. The operator can adjust gain for optimal view. The signal is not being recorded in Standby mode once the system is stable and signal quality is acceptable start the recording by pressing the Baseline

Standby mode is for assessing signal quality and assuring system stability before recording.




Figure 27 - Baseline

# 4.4.5 Occlusion Stage

Follow instruction in 6.3.2 for performing a correct occlusion. Once the blood pressure

grayed out on the study timeline. A new Occlusion bookmark will be displayed, progressing on the timeline as new signals are acquired.

Review the quality of occlusion by inspecting the occluded signal at MAX Gain.

If needed, increase pressure in the blood pressure cuff to improve occlusion quality.

Occlusion Stage timer ( ) is displayed, displaying time elapsed since the stage started and the recommended time for this stage. If stage elapsed time exceeds the recommended time, a "+" sign is displayed before the timer.

When Occlusion Stage timer reaches the recommended time, the Post-Occlusion Stage

icon becomes enabled (Post-Occlusion ) allowing the transition to Post-Occlusion Stage.

Occlusion time is 5 minutes and should not be extended even if additional pressure is required to improve occlusion quality following review of occlusion quality.

When the timer displays exactly 5 min, quickly release the air from the blood pressure

## 4.4.6 Post occlusion Stage

Click on the Post-Occlusion Stage icon ( Post-Occlusion ) to start the Post-Occlusion Stage timer and timeline. The icon is changed ( Post-Occlusion ) to reflect that the stage is active.

Baseline and Occlusion Stage bookmarks will be displayed greyed out on the study progression viewer and a new Post Occlusion bookmark will be displayed, progressing on the timeline as new signals are acquired.

Click on Max Gain button to return to original signal Gain setting.

When stage time reaches the recommended time, the Finish Test button ( ) is enabled. Click on the Finish Test button to conclude the test. Probes will deflate automatically, and the following message will appear.




Figure 29 - Study Screen

## 4.4.8 Stopping the Study

At any point during the study, you may click on the Stop Test button (This will automatically release the air pressure and deflate the probes. Stopping a test at any point after "Standby" will stamp the probes as "used" and new probes should be attached if restarting the study. In addition, visit number will need to be adjusted in the repeat study.

## 4.4.9 Operational Warning and Error Indications

When an unwanted system condition is detected when running the study, the user is provided with error / warning indication at the bottom of the screen.




Figure 31 - Detail of Error




Figure 34 - Patient Record - Doctor View




Figure 35 - Patient Record - Doctor View: Single Study Review Options

- Editing Toolbar
  - Undo and Redo last change
  - Wand tool to automatically define study stages
  - o Eraser to remove all occlusion borders
  - o Manual Occlusion button to choose occlusion borders manually.
- Study Results
  - o Calculated scores and parameters




Figure 37 - EndoPATTMx Study Review Main Screen

# 4.5.4 EndoPAT<sup>TM</sup>x Study Editing

#### 4.5.4.1 Automatic Analysis

Automatic analysis is performed by clicking on the Wand button in the Editing Toolbar. Stage bookmarks are placed and signals that do not pass qualification criteria are excluded.

## 4.5.4.2 Adjusting stage bookmarks

Once automatic analysis is performed (see 4.5.4.1), Occlusion bookmarks are displayed on the PAT<sup>TM</sup> Waveform Viewer. You can adjust the stage timing by dragging the bookmark.

Hover the mouse over the bookmark until the mouse icon is changed to the left button and drag to desired time. During the dragging, the study time of the marker is

indicated next to the occlusion headline



## 4.5.5 Manual Analysis (Manual Research Mode only)



#### NOTE

Since the manual analysis (T/B) does not incorporate certain mandatory features of the automatic analysis (e.g., contra-lateral arm correction and base line correction), it can serve for research purposes only (not necessarily endothelial dysfunction applications).



#### NOTE

To enable the Manual Analysis functions, it is necessary to enable the Manual Research Mode by Itamar Medical technician

### 4.5.5.1 Marking Segments and Artifacts

Tool bar icons provide quick and easy access to the tools used to mark segments and artifacts in research studies, as well as to facilitate automatic ratio calculations between PAT<sup>TM</sup> traces recorded at different time segments. This feature can define any number of time intervals as artifacts, and thereby exclude them from the ratio calculations.

You can mark segments in the Trace Window, identifying three segment types (later to be used in calculations):

- B (Baseline) segment
- T (Test) segment
- A (Artifact) segment

To Mark a Segment

- 1. Set Baseline, Test or Artifact on the segment selection area.
- 2. In the Trace Window, position the mouse's cursor at the beginning of an interval to be marked.
- 3. Drag the cursor horizontally along the interval the selected segment becomes highlighted.
- 4. Release the mouse button at the end of the desired interval the selected segment remains highlighted, and headline indicates its type.




Figure 38 - Manual Research Mode Analysis and Signal View Screen

### 4.5.5.2 Analysing PAT<sup>TM</sup> Ratios

After the B and T segments are marked, their PAT<sup>TM</sup> ratios can be calculated by clicking T/B icon and then displayed in the left side of the screen. Note that these results might be slightly different from the automated analysis, as this tool doesn't include all the analysis logic.



Calculated segment ratios displayed in the left side of the screen do not have clinical implication. This feature is used only for research purposes and should not be regarded as device output concerning Endothelial Dysfunction.

# 5 Preparing for a Study

## 5.1 Preparing the System for a Study

Accessories that are required beside the EndoPAT<sup>TM</sup>x system:

- A set of two single-use PAT<sup>TM</sup> probes and anchors
- Blood pressure cuff (capable of sustaining high pressures for 5 minutes)
- Adhesive tape
- Pair of arm supports



#### WARNING

Inspect the system, cables, and accessories for mechanical damage.


The use of damaged equipment may impact patient and operator safety and system performance.

Switch on the computer and the EndoPAT<sup>TM</sup>x device. Launch the EndoPAT<sup>TM</sup>x software and login to the system.

### 5.2 Connecting the PAT™ Probe




Figure 41 - Clicking in

Connect two new probes by inserting the connector tab into each probe slit (see Figure 40) and pressing the connector down onto the probe until the tab of the probe clicks into place (see Figure 41).






Figure 42 - Press to release

To remove probes, press the tab (clip) marked by the arrow in Figure 42, and pull the connector away from the probe (Figure 43). Used probes should be disposed properly.

## 5.3 Creating/Updating Patient's Record

- 1 Search for existing Patient (4.3.1) or create a new patient record (4.3.2).
- 2 Update or enter manually current patient details as follows:

All mandatory fields are marked with asterisk and must be filled to proceed to the next step. The field description is as follows:

• Patient ID - Enter patient identification number or identifier (mandatory field). This identifier must be unique within the clinic.



#### NOTE

The system will not allow creation of Patient ID that is already in the system.

- Patient First and Last name Enter the patient's complete name, initials, or another identifier.
- Date of Birth Enter the patient's month, day, and year of birth. This can be done manually, or by pressing the arrow key until the correct value appears in the window (mandatory field).
- Gender select either male or female (mandatory field).
- Patient Height and Weight mandatory fields. Units are set according to the computer defaults either centimeters and Kg or feet-inch and lbs.
- Diastolic Blood Pressure mandatory field, unless the "Fixed pressure" mode was selected in the set-up screen.
- Systolic Blood Pressure mandatory field, unless the "Fixed pressure" mode was selected in the set-up screen.



## NOTE

All text fields should be entered using text letters and numbers.

3 Enter/update Patient's Risk Factors - Select the risk factor method (Framingham Risk Score, European Risk Score or Reynolds Risk Score) and fill in the additional inputs required to calculate Cardio-vascular Risk Factor. See Table 1 – Risk Factors mandatory fields below.

Use the blood pressure cuff-set provided by Itamar Medical for arm occlusion.

Usage of non-certified cuff- might compromise the results.

## 6.1.1 General description

The EndoPAT<sup>TM</sup> system is comprised of a system console and two independent sensing probes coupled to connecting pneumo-electric tubing and foam finger mounting rings. The system console is connected to a computer loaded with a specific program for controlling the EndoPAT<sup>TM</sup> system. The system console has two separate external buttons for inflating and deflating the probes. The probes can be inflated and deflated via the computer program as well.

The eligibility of a patient for an EndoPAT<sup>TM</sup> study is entirely at the discretion of the patient's physician, and is generally based upon the following criteria:

- · Symptoms and complaints
- Medical history
- · Risk factors
- Current medications
- Restrictions on use (Section 1.5)

## 6.1.2 System warm up

The system should be turned on and allowed to warm up for at least 20 minutes before commencing patients' studies. It is recommended that the system would not be turned off until the last study for the day has been completed.

## 6.1.3 Pre-study adaptation period

Thermoneutral room temperature must be maintained at all times: 22°C-24°C (70°F-75°F).

Any restrictive clothing that could interfere with blood flow to the arms should be removed. Heavy coats or clothes with thick sleeves should not be worn. Watches or rings or other jewelry on the hands and fingers should be removed.

The blood pressure cuff should be applied snuggly, but without excess pressure, which might hamper venous blood return, causing venous pooling in the arm (which is deleterious to the test performed).

The patient should then be comfortably seated or allowed to lie down in the study room and relax for at least 15 minutes or a sufficient period to reach a relaxed cardiovascular steady-state and to adjust to the room temperature.

## 6.1.4 Patient blood pressure measurement

The blood pressure measurement procedure may affect the vascular conditions of the patient. Therefore, if blood pressure measurement needs to be taken prior to the EndoPAT<sup>TM</sup> study, the following should be considered:

- The blood pressure should be measured from the patient's control arm (the arm that is not occluded during the EndoPAT<sup>TM</sup> study).
- It is recommended to allow 30 minutes between the time of the blood pressure measurement and commencement of the EndoPAT<sup>TM</sup> test.

## 6.1.5 Positioning the patient

The patient should sit in a reclining chair or lie down comfortably. In either case the patients' hands must be supported at approximately heart level.

## 6.1.6 Preparation of fingers and hands before a study

The finger should be inspected for any deformities or injuries that could affect the study. The probe should not be used on a finger that is cut, injured or unusually sensitive. Fingernails should be trimmed and filed if necessary to avoid damaging the internal membranes of the PAT<sup>TM</sup> probes & displacing the finger from the sensing region of the probe, resulting in a smaller PAT<sup>TM</sup> signal and inaccurate results. The index finger is the recommended finger for the study, however if this finger is too large to comfortably fit into the probe or is otherwise unsuitable (see above), a different finger (except the thumb) may be used, as long as it is the same finger in both hands.



#### WARNING

Long nails may cause distorted PAT<sup>TM</sup> signals and may cause the study to fail.

Before inserting the fingers into the probes, ensure all heavy clothes, tight fitting sleeves, rings, watches, and jewelry were removed from patient's hands and arms.

### 6.2 Patient and System Setup

## 6.2.1 Study conditions

The study should be conducted in a quiet and relaxed atmosphere. Phones, beepers, and other devices which can cause startling noises should be turned off; otherwise, the startle effect on the patient might affect the test result. The patient should be kept comfortable and fully relaxed and asked to refrain from talking. Staff should avoid talking to the patient and between themselves as much as possible. These conditions should be kept throughout the entire study.

To avoid communication problem, make sure there are no other applications running on the system's computer, and the device is connected to the computer and to the electricity.

## 6.2.2 Initializing the EndoPAT<sup>TM</sup>x system

Activate the EndoPAT<sup>TM</sup>x application. Enter patient details and study parameter as required.

Ensure that the pneumo-electric tubes are properly connected to the EndoPAT<sup>TM</sup>x device, and a new set of probes is connected. If the probes have been used, a warning message will be displayed when you try to inflate the probes.

## 6.2.3 Patient preparation

First, ensure that a blood pressure cuff is placed on the designated test arm. Then, the PAT<sup>TM</sup> probes should be placed inside the appropriate sockets of the arm-supports (see Figure 44 Figure 45-1). Fully deflate the probes by clicking the Defalte button in the application or by pressing the "Deflate" button on the device.

Place the study fingers into the probes, making sure the fingers are inserted all the way to the end of the probe (see Figure 44 - Applying the PAT<sup>TM</sup> probes). Inflate probes by pressing the Inflate button on the device or clicking the "Inflate probe" button in the application.



## NOTE

The index fingers are preferred; however, any finger (other than the thumb) may be used, provided that the same finger is used on both hands.

Place the blue foam anchor ring on the adjacent finger to the one with the probe on. The anchors should be placed as far back as possible on the finger so that they do not come in contact with the PAT<sup>TM</sup> probe (such contact may result in mechanical artifacts during recording) – see troubleshooting guide (Appendix C).



Figure 44 - Applying the PAT<sup>TM</sup> probes

Make sure the tubing forms a loop from the probe, back to the anchor as shown in Figure 44. The patient should be instructed to refrain from moving the fingers to the extent possible. Both patients' forearms should be supported on the arm supports. Make sure that the probes are free from contact with any object (including the supporting surface), as shown in Figure 45.

### 6.3 Performing the Study



#### **NOTE**

Do not change the time or date of the computer during the study. Changing the windows time while recording might result in corrupted study.

## 6.3.1 Recording baseline

1. Click the **STANDBY** icon, from the main screen. The system will display the signals from the two PAT<sup>TM</sup> channels, allowing the user to check the signals and adjust the signal gain to properly visualize the PAT<sup>TM</sup> signals. Signals from both PAT<sup>TM</sup> channels (Probe A and Probe B) appear in the Trace Window. Visually inspect the PAT<sup>TM</sup> signal for at least 1 minute. If the signal seems noisy, make sure that the probes are not in touch with anything. As the system equilibrates, having a few leaks in the first few minutes is normal. If you encounter more than 2-3 leaks per minute, continue in Stand By mode for a few more minutes, until at least a minute passed since the last leak, or refer to the troubleshooting section (Appendix C).



#### **NOTE**

Cold fingers will have small PAT<sup>TM</sup> signals, with higher noise levels.



#### NOTE

While in the **Standby** stage, it is possible to stop the test, deflate & re-inflate the probes without losing the usability of the probes. Once **Baseline** is pressed the probes cannot be reused after the **Stop Test** button is pressed.



#### NOTE

While in the Standby mode, data is not recorded.

Click the BASELINE icon to begin study recording.

## 6.3.2 Performing arterial occlusion

After a stable period of the required baseline signal recording (5-6min.), prepare for the occlusion:

- 1. Select Max Gain button of the occluded arm (either probe A or probe B).
- 2. Inform the patient you are about to inflate the blood pressure cuff, stressing the importance of remaining still during the test.
- 3. **Rapidly** inflate the blood pressure cuff to a supra-systolic level (the recommended pressure is at least 60mmHg above systolic blood pressure and no less than 200mmHg). Verify total cessation of blood flow to the hand (as reflected by a total absence of PAT<sup>TM</sup> signal from the occluded hand). If the appearance of any PAT<sup>TM</sup> signal is noted, increase cuff pressure by an additional 50 mmHg and up to 300mmHg (See Figure 46).



### Warning

Inflating the BP cuff might cause some stress and discomfort to the patient. Pay attention to the patient's well-being.


4. Maintain the arterial occlusion for exactly five minutes – periodically check the pressure in the occluding cuff is maintained; increase pressure if required.



#### NOTE

Once the occlusion has been performed the test should not be re-started.

It is recommended to wait at least 2 hours prior to performing a new study.

## 6.3.3 Post Occlusion period

When exactly five minutes have passed, deflate the pressure cuff as quickly as possible.

- 1. Continue to maintain the relaxed conditions throughout this period. The patient might experience discomfort after the cuff deflation & might feel an urge to move the test arm. This should be discouraged.
- 2. When post occlusion is complete (5 minutes), stop the study by clicking the **Finish Test** button.

## 6.3.4 After the Study is Completed

Clicking the **Finish Test** button ends the recording. This will also deflate the probes automatically, allowing their removal from the patient's fingers. Carefully remove the PAT<sup>TM</sup> probes, anchors, and the blood pressure cuff from the patient. Disconnect the PAT<sup>TM</sup> probes and discard them. As it is impossible to visually differentiate used from unused probes, we recommend placing a piece of tape around each used probe prior to discarding the probes.



#### **NOTE**

If the probe doesn't deflate after ending the study with the **Finish Test** button, manually deflate via the deflate button on the device. This button can also be used in case of emergency for deflating the probe during test.

After completion of a study the study signal will be automatically opened on the screen.

# 7 Review and Analysis

During a PAT<sup>TM</sup> study, recorded signals are viewed in the display window, based on the appearance of the traces, a qualitative evaluation can be performed. However, subsequent review of the study using the special features described in this chapter facilitates a quantitative analysis of the acquired data.

It is recommended to review each study upon completion of its recording.

## 7.1 Study Data Retrieval

Locate the desired study by searching for the patient record and selecting the EndoPAT<sup>TM</sup>x study or from the list of recent EndoPAT<sup>TM</sup>x studies (4.5.2).

Selecting the desired study opens the Study PATTM Signal Review Screen (4.5.3)

### 7.2 Automatic Analysis

Click the Wand



Icon in the editing toolbar to perform the automatic analysis.

The automatic analysis identifies the occlusion borders and marks with two vertical lines its beginning and end and marks the whole signals area between these two lines in grey. Proper identification of the occlusion area is critical for the automatic analysis to correctly select the regions and time references used in its calculations. The user should verify that the marking of the occlusion area appears properly. If the automatically marked occlusion area appears wrong, it can be manually corrected as described in section 7.2.1.

If manual corrections are performed, click the Wand based on edits performed.



Icon to perform the analysis

Study results will appear in the Study Results section (4.5.3).

The RHI (Reactive Hyperemia Index) or LnRHI (natural log of RHI) is the post-to-pre occlusion PAT<sup>TM</sup> signal ratio in the occluded arm, relative to the same ratio in the control arm, corrected for baseline vascular tone of the occluded arm where:

Normal EndoScore<sup>TM</sup>: RHI > 1.67 or LnRHI > 0.51 Abnormal EndoScore<sup>TM</sup>: RHI  $\leq$  1.67 or LnRHI  $\leq$  0.51

The HR (Heart Rate) is calculated from the PAT<sup>TM</sup> signals in the baseline region of interest.

### 7.2.1 Manual Correction of the Occlusion Borders

Click the magic wand to create the automatic analysis borders.

Select the occlusion borders as follow:

Once automatic analysis is performed (see 4.5.4.1), Occlusion bookmarks are displayed on the PAT Waveform Viewer. You can adjust the stage timing by dragging the bookmark.

Hover the mouse over the bookmark until the mouse icon is changed to the left button and drag to desired time. During the dragging, the study time of the marker is indicated next to the headline occlusion (05:05)

Once the manually selected occlusion is marked, click on the magic wand icon to run the automatic analysis using the manually selected occlusion area.



#### NOTE

Manual changes of the occlusion borders are automatically saved

### 7.3 Study Report

To review the study report, select the "View report" option.

The Report contains data about the patient, the study, traces of the signals and the basic results (RHI/LnRHI and HR).

# 7.4 EndoPAT<sup>TM</sup>x study results

#### 7.4.1 EndoScore<sup>TM</sup> result: RHI and LnRHI

The RHI (Reactive Hyperemia Index) is the post-to-pre occlusion PAT<sup>TM</sup> signal ratio in the occluded arm, relative to the same ratio in the control arm, corrected for baseline vascular tone of the occluded arm where:

Normal: RHI > 1.67 Abnormal: RHI  $\leq$  1.67

This index and threshold were used in the validation study presented at section 1.2 of this manual and they reflect endothelial function.

The LnRHI is a natural log transformation of the same index, where:

Normal: LnRHI > 0.51Abnormal:  $LnRHI \le 0.51$ 

This transformation is a monotonic transformation; therefore, it does not change the dichotomous diagnosis (normal/abnormal) for any individual test.




Figure 47 – non selective population histograms of RHI




Figure 48 - non selective population histograms of LnRHI

LnRHI provides a better double-sided distribution that is very close to normal distribution (Gaussian) in its nature. The histograms of RHI and LnRHI (based on the analysis of large dataset of nonselective populations) are shown in Figure 47 and Figure 48 respectively (blue represents the actual numbers and red represents the calculated equivalent normal distribution of the same mean and standard deviation).




Figure 49 - LnRHI distribution in non-selective population

The LnRHI distribution curve in a non-selected population is included in the report (Figure 49) and displays the LnRHI result in respect to non-selected population.

The graph presents the distribution function of the LnRHI in the non-selected population. The data used is composed of nearly 10,000 data points collected from different study cohorts worldwide.

The mean / median LnRHI in the population (0.7, marked in blue) and the dichotomy

threshold for normal endothelial function (0.51, marked in red) are presented as vertical lines on the graph.

The individual EndoScore<sup>TM</sup> result of the patient is presented on this graph (bold black line and a result frame) to aid assess the patient condition in respect to the dichotomous threshold and the general population.

In case that Endothelial Function Index in the software is set to RHI and not to LnRHI, the same LnRHI graph will appear and the RHI values (threshold, population median/ mean, and study results) will appear in brackets next to the LnRHI values in the graph.

#### 7.4.2 Heart Rate

The HR (Heart Rate) is calculated from the PAT<sup>TM</sup> signals in the baseline region of interest.

### 7.4.3 Analysis Errors

The user may encounter a system error message when running the automatic analysis. Such an error would disqualify the results of the analysis. Some of the errors may be corrected after proper re-marking of the manual occlusion (if the errors are caused by a wrong automatic detection of the occlusion borders). However, some errors have no user corrective actions that can remedy these situations. All error messages indicate that the system could not complete the analysis of the study. Consequently, RHI result is not provided and "N/A" or "0" is presented instead of the calculated value. (please note: in a normal adequate operation of the system the algorithms that calculates RHI is never supposed to provide a "0" result).

Table 3 in section 9.3, provides a list of system error messages.

#### 7.5 Study printing

You can print the displayed data at any time during off-line review and analysis by selecting the Print option through Windows pull down menu.

## 8 Maintenance

#### 8.1 Device maintenance

This chapter describes preventive and regular maintenance for the EndoPAT<sup>TM</sup>x system.

Only qualified medical personnel should use this equipment. In the event of equipment malfunction all repairs should be executed by qualified Itamar Medical personnel or authorized service agents.

Maintenance instructions should be followed closely to avoid unnecessary equipment failure or potential health hazards to the user or patient.

- 1. Inspect all cords and ensure they are not frayed or damaged. Verify that all plugs, connectors, and cables are securely connected. Gently wrap tubes around the rear panel of the device.
- 2. The EndoPAT<sup>TM</sup>x device should be free of dirt and debris. Using a soft, slightly damp cloth, gently wipe the exterior of the EndoPAT<sup>TM</sup>x device, avoiding contact with open vents and plugs.
- 3. Used probes should be discarded after each use and replaced with new ones.



#### NOTE

When the device is stored or not used for long durations, it is recommended to keep the probes connected to their connector. This would prevent dust and humidity from entering the device's pneumatic system.

## 9.2 System Error Messages

The following table provides a list of system error messages that the user may encounter when running the analysis. Some of the errors may be corrected after proper manual occlusion marking (if the errors are caused by a wrong automatic detection of the occlusion borders). However, some errors have no user corrective actions that can remedy these situations. All error messages indicate that the system could not complete the analysis of the study.

ShortSignal	Short Signal i.e. the recorded signal length is less than the minimum required to run an analysis (6 min).
LongSignal	Long Signal i.e. the recorded signal length is more than the maximum allowed to run an analysis (150 min).

ShortBaseLine	Short Baseline i.e. baseline duration is shorter than minimum required less than 2 min and 20 sec valid baseline signals.

LongOccLength	Long Occlusion i.e. Occlusion Time more than maximum allowed.  More than 10 min occlusion (might be rectified after manual occlusion marking).




